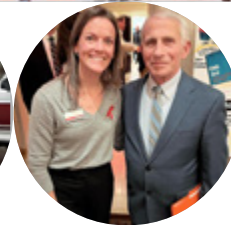
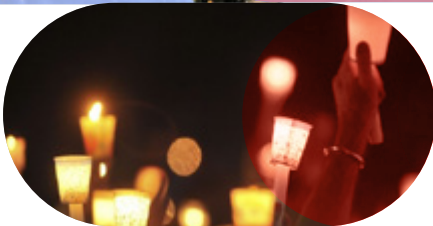

Introduction

Our Team

Our staff is made up of 15 dedicated, talented and collaborative individuals committed to providing a high level of care for people impacted by HIV/AIDS in Maine. With diverse experiences and backgrounds, we work as a team to support each other and those we serve.

Our Board

Our Board of Directors dedicates their time, resources and unique expertise across a variety of professional sectors to support and guide the agency’s programs and strategic direction.

Our Services

Case Management. Comprehensive specialized care coordination that assists individuals living with HIV/AIDS achieve and maintain health stability. This includes linkage to health coverage, medical care, medications and wrap-around services that address food insecurity, housing, mental health, substance use, and transportation.



Housing. Administering statewide federally funded housing grants that include a subsidy program as well as short-term rent, mortgage and utility assistance for people in Maine living with HIV/AIDS. These “HOPWA” grants are the only HUD-funded program that includes additional supportive services such as case management and transportation assistance.



Prevention. Free, low-barrier, confidential HIV and Hepatitis C Testing Services and Linkage to Care. FPC performs over 400 in-person tests annually and administers the state’s largest self-test kit program, distributing over 1000 free HIV self-test kits in partnership with 20 organizations across the state.

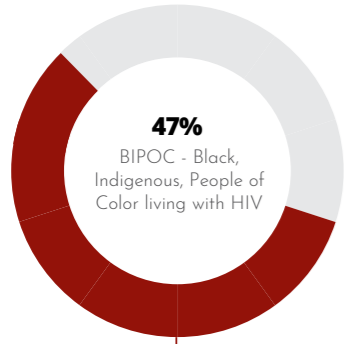


Advocacy. FPC serves on the National HIV/AIDS Housing Coalition Board of Directors, The Advisory Council to the US Business Action to End AIDS, Maine’s HIV/AIDS Advisory Committee and serves as the Provider co-chair of Maine’s HIV/AIDS Advisory Board. Together with partners and community, we have expanded access to HIV prevention services through state legislation and contributed to increased funds for Federal HIV/AIDS Housing Grants.



DEMOGRAPHICS

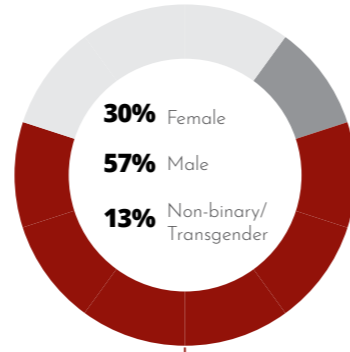
People Enrolled in HIV Case Management:



83% of individuals enrolled in case management are low-income, with over half living at or below 100% of the Federal Poverty Line.

Individuals range in age from 6 to 81 years of age.

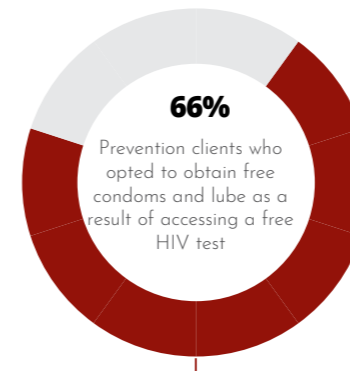
People Accessing Prevention Services:



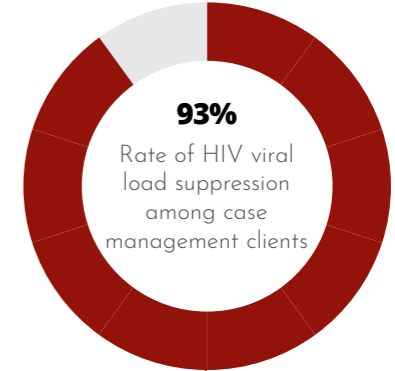
100% of clients receiving a test report more than one risk factor for acquiring HIV.

Health Outcomes + Response



Half of people receiving an HIV test had never heard of PrEP and were provided with education and referral resources.



Viral load suppression is a key indicator of health with HIV, and prevents HIV transmission. National rate is below 70%

30% of people report never having been tested for HIV.

Program Enhancement Since 2019

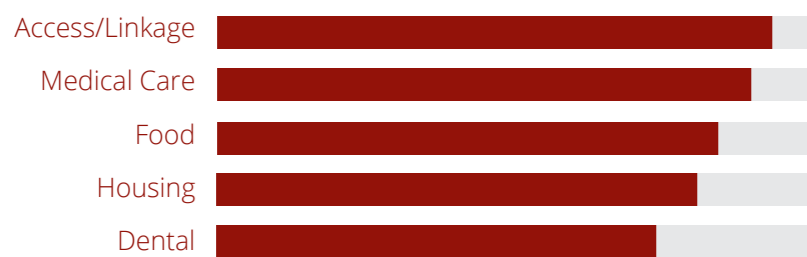


FPC serves around 400 people annually through case management and housing. The increases shown to the left indicate significant growth in financial assistance provided annually to our client base.

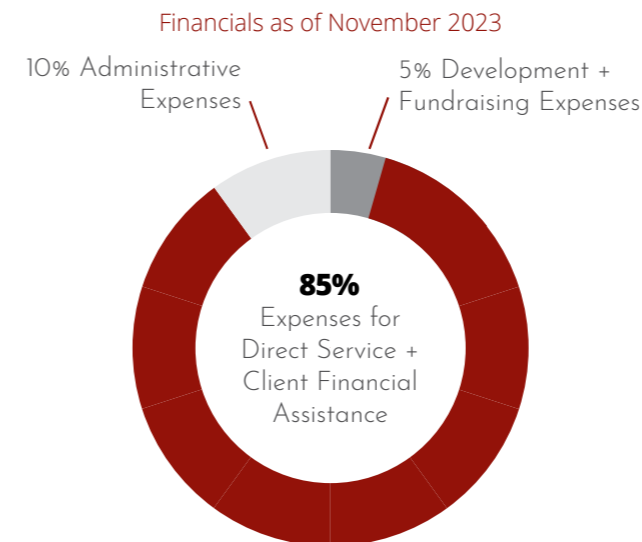
Direct client financial assistance helps with critical needs including durable medical equipment, medication copays, emergency food cards, transportation, and dental care.

Increase to testing is a direct result of the addition of HIV self-test kit distribution reaching more individuals throughout Maine.

Top 5 Needs Reported Among Clients Enrolled in HIV Case Management:



Clients work with their case manager to develop care plans and goals, which inform service delivery. Progress toward goals and health outcomes are monitored and reviewed routinely. Goals are adjusted as necessary.

Amicus Brief | US Court of Appeals for the Fifth District

Filed along with 24 other HIV and Hepatitis Organizations in support of the US Government in Braidwood Management v. Bacerra | June 23, 2023

"The United States Preventive Services Task Force ("USPSTF") and its recommendations have been essential to the prevention of HIV, hepatitis, and many other infectious and chronic diseases for millions of Americans. After the passage of the Affordable Care Act ("ACA"), USPSTF's recommendations became a critical first step in ensuring effective interventions are covered by health insurance. A wholesale invalidation of the coverage requirement for USPSTF's recommendations would strike a critical, unnecessary, and costly blow to the battle to end HIV, hepatitis, and other infectious diseases."

US Business Action to End HIV

Expanding Access to Care Through Community Pharmacies

In November, 2023, FPC Board member, Tiffany Townsend, NP AAHIVS, and FPC Executive Director, Katie Rutherford, attended advocacy meetings as panelists and advisory members with business leaders, public health experts, and the Office of National HIV/AIDS Policy as part of a national effort to expand access to HIV care in community pharmacies.
